RESOLUTION NO. SP **2559**, S-2004

A RESOLUTION REQUESTING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO INCLUDE IN HIS PRIORITY PROJECT FOR PUBLIC INFRASTRUCTURE FOR THE YEAR 2004 THE DRAINAGE IMPROVEMENT AND CONCRETING OF KAPILIGAN AND ZARAGOSA STREETS, BARANGAY DOÑA IMELDA, QUEZON CITY, AND THEREBY AUTHORIZING HIM TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE SAME ABOVE-MENTIONED PURPOSE.

WHEREAS, Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides, to wit:

“Every local government units shall exercise the powers expressly granted x x x as well as powers necessary to x x x, promote health and safety, x x x and preserve the comfort and convenience of their inhabitants.”

WHEREAS, said street are the only streets left for improvement, considering that other streets surrounding Barangay Doña Imelda were already addressed for its improvement;

WHEREAS, the condition of said streets have long been nuisance to the inhabitants of Barangay Doña Imelda, more particularly to the tricycle drivers who are religiously working to earn money to support the daily expenses of their families;

WHEREAS, said streets have perennially been in dilapidated condition and always require regular asphalt patching due to its soft base;

WHEREAS, the City government has seen the need to improve the said streets in order to maximize its role in serving the public;

WHEREAS, the City government, in the interest of the general public, decided that this is the opportane time to push with the improvements of the said streets in as much as the rainy season is fast approaching;

WHEREAS, the City Mayor is hereby given the authority to enter into a negotiated contract with any reputable and City accredited construction corporation for the drainage improvement and concreting of Kapiligan and Zaragosa Streets, Barangay Doña Imelda, Quezon City.


NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby request, the Honorable Feliciano R. Belmonte, Jr., City Mayor, this City, to include in his priority project for Public Infrastructure for the Year 2004, the drainage improvement and concreting of Kapiligan and Zaragoza Streets, Barangay Doña Imelda, Quezon City.

RESOLVED, FURTHER, to authorize, as it does hereby authorize, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable and Quezon City accredited construction corporation for the same above-mentioned purpose.


