A RESOLUTION REQUESTING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO DIRECT THE QUEZON CITY ENGINEERING DEPARTMENT TO DREDGE THE MARIBLO CREEK SO AS TO PREVENT THE FLOODING OF THE NEARBY BARANGAYS IN DISTRICT I.

WHEREAS, the recent flash floods mainly attributed to the overflow of Mariblo Creek devastatingly affected nearby barangays in District I;

WHEREAS, in order to protect the welfare of our communities, it is necessary to immediately order the dredging of the Mariblo Creek so as to declogged the creek from harmful waste materials and to avoid possible calamity due to flash floods;

WHEREAS, the Quezon City Engineering Department has the necessary equipment to effect the said dredging and to rid the sewers of the massive garbage accumulated thereat;



WHEREAS, to further alleviate the condition of the said creek, it is necessary to clear the same of rubbishes being the main access pipeline for household drainage system.


NOW, THEREFORE,


