A RESOLUTION URGING THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA), TO CONSTRUCT/INSTALL FOOTBRIDGE ALONG MINDANAO AVENUE BRIDGING ROAD 3 OF BARANGAY PROJECT 6 AND ROAD 11 OF BARANGAY PAG-ASA, DISTRICT I, QUEZON CITY.

WHEREAS, there is at present no footbridge installed along Mindanao Avenue bridging Road 3 of Barangay Project 6 and Road 11 of Barangay Pag-Asa, District I, Quezon City;

WHEREAS, there are numerous incidents of vehicular accidents in the said area causing great inconvenience and danger to the motorists and pedestrians passing thereat;


WHEREAS, it is necessary to immediately construct/install footbridge in the said area so as to ensure safety and provide security for the motorists and the commuting public, further avoiding the recurrence of accidents thereat;

WHEREAS, in order to protect the welfare of its constituency, the City Council resolved to urge the Metro Manila Development Authority (MMDA) for the urgent installation of the said footbridge.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the Metro Manila Development Authority (MMDA) to construct/install footbridge along Mindanao Avenue Bridging Road 3 of Barangay Project 6 and Road 11 of Barangay Pag-Asa, District I, Quezon City.
