A RESOLUTION REQUESTING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ALLOCATE NECESSARY FUNDS FOR THE PURCHASE OF ONE (1) FIRE TRUCK FOR BARANGAY PROJECT 6, DISTRICT 1, QUEZON CITY.

WHEREAS, the Barangay Council of Barangay Project 6 through their Barangay Chairman Mario M. Nuffez has unanimously expressed their intention to seek the assistance of the City Council for the immediate purchase of one (1) Fire Truck for Barangay Project 6, District 1, Quezon City;

WHEREAS, there is at present a community Fire Station particularly located at Barangay Project 6 with no serviceable Fire Truck available considering the insufficiency of funds of the Barangay to purchase the same;

WHEREAS, there is a need to immediately provide the same so as to ensure the safety and protection of its constituency and properties as well as its neighboring communities caused by incidents of conflagration;

WHEREAS, in order to carry out its purpose, it is necessary to allocate funds for the immediate purchase of One (1) Fire Truck for the aforesaid barangay.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby reguest, the Honorable Feliciano R. Belmonte, Jr., City Mayor, this City, to allocate necessary funds for the purchase of One (1) Fire Truck for Barangay Project 6, District 1, Quezon City.
