*A RESOLUTION URGING THE 142 BARANGAYS IN QUEZON CITY TO IDENTIFY AND DESIGNATE AN EVACUATION AREA IN THEIR RESPECTIVE BARANGAYS TO BE UTILIZED IN THE OCCURRENCE OF DISASTERS OR NATURAL CALAMITIES.*

*WHEREAS, the City Council is mandated to protect the welfare of its constituency from various dangers detrimental to the safety of the community;*

*WHEREAS, there is at present no designated evacuation area within barangays in Quezon City particularly determined to be utilized in the occurrence of conflagrations, earthquakes, epidemic or other calamity or misfortune;*


*WHEREAS, the said area required would prevent the incidents of stampedes due to immediate dislocation of residents, unnecessarily resulting to loss of lives and properties;*

*WHEREAS, it is necessary to identify and designate such evacuation area in order to carry out the aforesaid purpose and to eliminate the possibility of future mishaps caused by negligent, irresponsiveness and unpreparedness of the barangays in reacting to such incidents.*


NOW, THEREFORE,
