A RESOLUTION REQUESTING THE COMMISSION ON ELECTION OF QUEZON CITY (COMELEC-QC) TO CONDUCT A PLEBISCITE RELATIVE TO ORDINANCE NO. SP-1616, S-2005, APPENDING THE WORDS MOUNT CARMEL TO EXISTING BARANGAY NAME OF BARANGAY PROJECT 6.

WHEREAS, the City Council has already approved Ordinance No. SP-1616, S-2005, appending the words Mount Carmel to existing Barangay name of Barangay Project 6, thus, making the new Barangay name as Barangay Mount Carmel, Project 6;

WHEREAS, further, the conduct of the said plebiscite is required so as to ascertain the concurrence and true sentiments of the majority of the residents of Barangay Project 6;

WHEREAS, it is necessary to request the Commission on Election of Quezon City (COMELEC-QC) for the said plebiscite so as to truly achieve the purpose of the constituency of Barangay Project 6 and to carry out the legislative intent of the City Council as mandated in the aforesaid ordinance;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request, the Commission on Election of Quezon City (COMELEC-QC) to conduct a plebiscite relative to Ordinance No. SP-1616, S-2005, appending the words Mount Carmel to existing Barangay name of Barangay Project 6.
