A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO STRICTLY IMPLEMENT ORDINANCE NO. SP-1510, S-2004, PRESCRIBING ADDITIONAL GUIDELINES IN THE IMPLEMENTATION OF REPUBLIC ACT NO. 6685, REQUIRING PRIVATE CONTRACTORS TO HIRE BONAFIDE RESIDENTS OF PROVINCE, CITY AND MUNICIPALITY IN WHICH THE PROJECTS ARE TO BE UNDERTAKEN, FOR THEIR LABOR REQUIREMENTS AND PENALIZING VIOLATIONS THEREOF.

*WHEREAS, it is necessary to strictly implement Ordinance No.
SP-1510, S-2004, prescribing guidelines so as to fully realize and
maximize the benefits offered for the implementation of Republic Act
No. 6685, requiring construction companies including the Department
of Public Works and Highways (DPWH) and contractors for
government-funded infrastructure projects to hire 30% of skilled and
50% unskilled labor requirements from the areas where the projects is
constructed / located;*
