RESOLUTION NO. SP. 396 S-2007 (PR2007-108)

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30, 000.00) TO THE BEREAVED FAMILY OF THE LATE SPO4 BONIFACIO D. DRACULAN, A RETIRED MEMBER OF THE QUEZON CITY POLICE DISTRICT (QCPD), WHO DIED ON APRIL 18, 2007, CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, SPO4 Bonifacio D. Draculan, a retired member of the Quezon City Police District (QCPD), had served the people of Quezon City starting as lowly Patrolman in 1972;

WHEREAS, during his tour of duty as Quezon City Police, he was instrumental in the apprehension of criminals and played a vital role in the maintenance of peace and order in the city;

WHEREAS, on April 18, 2007 SPO4 Dracular died of cardiopulmonary arrest causing his family to suffer financial difficulties as a result of hospitalization and funeral services;

WHEREAS, in recognition of his faithful, loyal and exemplary services, it is worthy to extend financial help to the surviving heirs of SPO4 Draculan.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the bereaved family of the late SPO4 Bonifacio D.
