
A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT #72-A BONIFACIO AVENUE, BALINTAWAK, BARANGAY PAG-IBIG SA NAYON, QUEZON CITY.

WHERBAS, petitioner Petron Corporation, thru their SSECM Manager Mr. Renato Abundo, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located at #72-A Bonifacio Avenue, Balintawak, Barangay Pag-ibig sa Nayon, Quezon City;

WHEREAS, gasoline service station are among the uses which require a Special Use Permit upon authorization from the Quezon City as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, the Barangay Council of Barangay Pag-ibig sa Nayon and the residents therein interpose no objection to the said gasoline station;



WHEREAS, Petron Corporation has complied with the requirements of the issuance of a Special Use Permit as required in Ordinance No. SP-918, S-2000, as amended, and its implementing rules and regulation, provided that the said petitioner shall comply with the existing zoning ordinance and special laws;

WHEREAS, the construction and operation of a gasoline service station will promote public welfare and for the development of our economy as well as for the increase of employment in our city.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Petron Corporation for the construction and operation of a gasoline service station located at #72-A Bonifacio Avenue, Balintawak, Barangay Pag-ibig sa Nayon, Quezon City.
