A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE SERVICE STATION LOCATED AT #72-A BONIFACIO AVENUE, BALINTAWAK, BARANGAY PAG-IBIG SA NAYON, QUEZON CITY.

WHEREAS, petitioner Petron Corporation, thru their SSEC Manager Mr. Renato Abundo, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of a gasoline service station located at #72-A Bonifacio Avenue, Balintawak, Barangay Pag-ibig sa Nayon, Quezon City;

WHEREAS, gasoline service station are among the uses which require a Special Use Permit upon authorization from the Quezon City as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, the Barangay Council of Barangay Pag-ibig sa Nayon and the residents therein interpose no objection to the said gasoline station;




