

WHEREAS, the City Engineering Office has recommended that the properties utilized by the school be acquired since aside from the existing school facilities, these lots are used as right-of-way of the school;

WHEREAS, the acquisition of the subject portion will decongest and better quality education services can be extended to more number of resident's thereunto.
