A RESOLUTION GRANTING BURIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY KAGAWAD LIBORIO A. PRADO OF BARANGAY DOÑA IMELDA, QUEZON CITY IN THE AMOUNT OF FORTY THOUSAND PESOS (P40, 000.00), TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, the late former Barangay Kagawad Liborio A. Prado of Barangay Doña Imelda, Quezon City died last June 24, 2007;

WHEREAS, the late Honorable Liborio A. Prado has served Barangay Doña Imelda as a Barangay Kagawad from 1982 to 1997 and a member of Lupon Tagapamayapa from 1998 up to the time of his death;


WHEREAS, during his term, the late former Barangay Kagawad had faithfully and selflessly served his constituents with integrity and honesty;

WHEREAS, the late former Barangay Kagawad truly deserves the distinct honor of his exemplary deeds during his lifetime and by way of appreciation, this city must not fail to grant his bereaved family financial assistance for burial as a token of gratitude from the City government.


NOW, THEREFORE,


