A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO MR. CONSANTINO P. ROSAS, WHO RETIRED FROM THE GOVERNMENT SERVICE AS CITY ASSESSOR OF QUEZON CITY ON APRIL 12, 1996, IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00), TO BE TAKEN FROM THE APPROPRATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE ANNUAL BUDGET FOR FISCAL YEAR 2008.
