A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER KAGAWAD ARIEL CAÑADA OF BARANGAY WEST KAMIAS, DISTRICT III, THIS CITY, IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00), TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
