*A RESOLUTION URGING THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA), TO CONSTRUCT/INSTALL TRAFFIC LIGHTS ALONG VISAYAS AVENUE CORNER ROAD 1 OF BARANGAY PROJECT 6, DISTRICT I, QUEZON CITY.*

*WHEREAS, there is at present no traffic lights installed along Visayas Avenue corner Road 1, Barangay Project 6, District I, Quezon City;*

*WHEREAS, the aforesaid area not only causes traffic gridlocks but likewise numerous vehicular accidents were reported in the said area causing great inconvenience and danger to the motorists and pedestrians passing thereat;*


*WHEREAS, it is necessary to immediately construct/install traffic lights in the said area so as to ensure safety and provide security for the motorists and commuting public, further avoiding recurrence of inconvenience and accidents thereat;*

WHEREAS, in order to protect the welfare of its constituency, the City Council resolved to urge the Metro Manila Development Authority (MMDA) for the urgent installation of the said traffic lights.


NOW, THEREFORE,
