A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO FILOIL GAS COMPANY, INC., TO CONSTRUCT AND OPERATE A FILOIL PORTAGAS REFILLING STATION AT BELFAST AVENUE CORNER MINDANAO AVENUE, BARANGAY PASONG PUTIK, FAIRVIEW, QUEZON CITY.

WHEREAS, petitioner FILOIL GAS COMPANY, INC., thru their President FRANCISCO G. PAGSICOLAN, a duly registered business entity under Philippine laws is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of Filoil Portagus Refilling Station located at Belfast Avenue corner Mindanao Avenue, Barangay Pasong Putik, Fairview, Quezon City;

WHEREAS, under Ordinance No. SP- 918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, the construction and operation the said Refilling Station is one of those requiring a Special Use Permit (SUP);

WHEREAS, the Barangay Council of Barangay Pasong Putik and residents and other business establishment therein interpose no objection to the said construction and operation;
