RESOLUTION NO. SP 3995_{S-2007} (PR2007-164)

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO MR. DOMINADOR BAUTISTA OCRISMA, WHO RETIRED FROM GOVERNMENT SERVICE AS CITY CULTURAL AND TOURISM AFFAIRS OFFICER LAST JANUARY 5, 1996, IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00), TO BE TAKEN FROM THE APROPRIATION FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, Mr. Dominador B. Ocrisma had faithfully served the Quezon City government as a rank and file employee and later as City Cultural and Tourism Affairs Officer;

WHEREAS, he had served the Administration of four (4) mayors, namely: Mayor Noberto S. Amoranto, Mayor Adelina S. Rodriguez, Mayor Brigido R. Simon, Jr. and Mayor Ismael A. Mathay, Jr.;

WHEREAS, his achievement during such distinguished tour of duty, founding member, Quezon City Hall Employees Athletic Association (QC HEAA) in 1970, founder Quezon City Brass Band in 1989 (now Quezon City Symphonic Band), successfully obtained a donation of an ambulance from Chiba City, Japan-Sister City of Quezon City, for the use of Quezon City Hospital (QCGH) in 1995;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to Mr. Dominador Bautista Ocrisma, who retired from government service as City Cultural and Tourism Affairs Officer last January 5, 1996, in the amount of Two Hundred Fifty Thousand Pesos (P250,000.00), be charged from Grants, Subsidies, and Contributions of the 2007 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
