A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO AUTOLPG CO. INC., FOR THE CONSTRUCTION AND OPERATION OF A LPG PUMP REFUELING STATION LOCATED AT NO. 39 MINDANAO AVENUE BOUNDARY BAGONG PAG-ASA, QUEZON CITY.
