RESOLUTION NO. SP398 S-2007a B (PR2007-199)

A RESOLUTION GRANTING A SPECIAL PERMIT TO PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) TO OPERATE AN INTERNET CASINO STATION (ICS) THROUGH AN ACCREDITED INTERNET OPERATOR AT LEVEL 3 ROBINSON'S PLACE, NOVALICHES, QUEZON CITY.

Introduced by Councilors FRANZ S. PUMAREN and RAMONP, MEDALLA.

WHEREAS, Philippine Amusement and Gaming Corporation (PAGCOR), a duly constituted/registered entity, is applying for a Special Permit from the City Council as a requirement for the issuance of business permit pursuant to Resolution No. SP-3153, S-2005;

WHEREAS, the applicant is authorized to operate an accredited Internet Casino Station (ICS) through an accredited internet operator pursuant to and as covered under the provision of PD 1869;

WHEREAS, the applicant is applying to operate an Internet Casino Station (ICS) at Level 3, Robinson's Place, Novacliches, Quezon City;

WHEREAS, the applicant has complied with the pertinent requirements in securing the said Business Permit.

NOW, THEREFORE.

BE II RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Philippine Amusement and Gaming Corporation (PAGCOR) to operate an Internet Casino Station (ICS) through an accredited internet operator at Level 3 Robinson's Place, Novaliches, Quezon City.

RESOLVED, FURTHER, that the Philippine Amusement and Gaming Corporation (PAGCOR) shall remit to the City Treasurer in lieu of all business taxes, a franchise fee of Three Percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that this resolution shall take effect Fifteen (15) days after approval.
