A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE KAGAWAD PEDRO F. CUADRA OF BARANGAY SANGANDAAN, DISTRICT II, THIS CITY IN THE AMOUNT OF FORTY THOUSAND PESOS (P40, 000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES, AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, his dedicated service to Barangay Sangandaan as Barangay Kagawad from 1980 to 1997 deserves recognition, as he earned the admiration and respect of his constituents, both as a public official and law-abiding citizen;

WHEREAS, the City government, as a token of gratitude for the humble service of its Barangay Officials, should convey sympathy and condolences by extending financial assistance to the bereaved family of the late Kagawad Pedro F. Cuadra.

Cuadra of Barangay Sangandaan, District II, this City, in the amount of Forty Thousand Pesos (P40, 000.00) to be charged from Grants, Subsidies, and Contributions of the 2007 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
