RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE KAGAWAD ROBERTO R. ESPINOSA OF BARANGAY HOLY SPIRIT, DISTRICT II, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40, 000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES, AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.




NOW, THEREFORE,


