A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR. TO EXTEND FINANCIAL ASSISTANCE TO THIRTY (30) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA ON AUGUST 7, 2007 AT KATIPUNAN STREET, BARANGAY COMMONWEALTH, DISTRICT II, THIS CITY, AT TWO THOUSAND PESOS (P2,000) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDS OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

Belmonte, Jr., City Mayor, to extend financial assistance to Thirty (30) families affected by the fire that razed a residential area on August 7, 2007 at Katipunan Street, Barangay Commonwealth, District II, this City, at Two Thousand Pesos (P2,000) per family owner and One Thousand Pesos (P1,000) per family renter/sharer which shall be taken from the Calamity or Emergency Funds of the City Government or from any other available funds in the City Treasury.
