A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HONORABLE NIDA SAMUDIO, FORMER SK CHAIRPERSON (BATCH 96) AND BARANGAY SECRETARY OF BARANGAY MANRESA, DISTRICT I, THIS CITY, IN THE AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) IN RECOGNITION OF HER DEDICATED AND EXEMPLARY SERVICE TO HER BARANGAY AND TO THE CITY, TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.


