A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FOOL AND DRUGS (BFAD) AND THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) SO AS TO ALLOW THE DISTRIBUTION OF METHERGIN AND OXYTOCIN TO GOVERNMENT-OWNED LYING-IN CLINICS/CENTERS IN QUEZON CITY.



WHERBAS, it is a State policy to ensure the protection and preservation of its community, and to adopt relevant regulatory measures for the welfare of its constituency;

WHEREAS, child births in government-owned lying-in clinics/centers utilize regulated drugs as Methergin and Oxytocin, necessary in every delivery and/or operation;

WHEREAS, it is imperative to authorize and allow the distribution of the aforementioned regulated drugs by the Quezon City Health Department (QCHD) to be used solely for the above purpose in lying-in clinics/centers in compliance with the pertinent rules and regulations relative thereto as promulgated by the Bureau of Food and Drugs (BFAD) and the Philippine Drug Enforcement Agency (PDEA);

WHEREAS, in order to fully realize and carry out the aforesaid intentions, it is necessary to enter into a Memorandum of Agreement (MOA) with the Bureau of Food and Drugs (BFAD) and Philippine Drug Enforcement Agency (PDEA) so as to allow the said distribution and not to impede the functions of local lying in clinics/centers within Quezon City, servicing and accommodating expectant mothers.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, this City, to enter into a Memorandum of Agreement with the Bureau of Food and Drugs (BFAD) and the Philippine Drug Enforcement Agency (PDEA) so as to allow the distribution of Methergin and Oxytocia to government owned lying-in clinics/centers in Quezon City.
