A RESOLUTION STRONGLY URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO DESIGNATE A SUITABLE DUMPSITE FOR THE DEBRIS AND OTHER WASTE MATERIALS RESULTING FROM THE OCCURRENCE OF FIRES IN VARIOUS PARTS OF QUEZON CITY AND TO DIRECT THE PROMPT DISPOSITION THEREOF.

WHEREAS, fires occur from time to time in Quezon City as a consequence of which the resulting debris and other waste materials are piled up at the conflagration site and remain uncollected for some time;

WHEREAS, the main reason for the accumulation of such debris and refuse is the absence of a corresponding dumpsite since the garbage collectors refuse to collect and dispose of them;

WHEREAS, the recent fires in Barangay Paltok and Barangay San Jose, this City, have brought about the situation already adverted to;

WHEREAS, strong consideration of health and environmental sanitation dictate that a dumpsite for such debris and waste materials be designated immediately to facilitate the prompt collection thereof;
