RESOLUTION NO. SP **4013**, S-2007
(PR2007-173)

A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF BARANGAY NAGKAISANG NAYON TO DISBURSE FUNDS FROM THE CALAMITY FUND FOR THE PROCUREMENT OF ABATE POWDER CHEMICALS AND TWO (2) LARCIVIDAL SPRAYER IN THE AMOUNT OF THREE HUNDRED SIXTY THOUSAND EIGHT HUNDRED SIXTY FIVE PESOS AND NINETEEN CENTAVOS (P360,865.19), THAT WILL BE USED FOR FUMIGATION AND SPRAYING IN PUBLIC AND PRIVATE OPEN SPACES AND OTHER PLACES, FOR THE CONTROL AND/OR ERADICATION OF MOSQUITOES CARRYING DENGUE WITHIN THE BARANGAY.

WHEREAS, Section 16 and 17 of the Local Government of 1991 provides that each local government unit ensures the efficient delivery of basic services including among others adequate health and social services to its constituents;

WHEREAS, Barangay Council of Nagkaisang Nayon passed Resolution No. SP-083, S-2007, authorizing the said purchase;

WHEREAS, there are reported cases of people who are sick of Dengue Fever within the barangay;

WHEREAS, with the occurrence of the outbreak of calamities or any form of emergency situations, there is a need to immediately institute preventive measures to address the same, which include procurement of Abate Powder Chemicals and two (2) Larcividal sprayer for the use in fumigation and spraying for the control or eradication of mosquitoes carrying dengue.



NOW, THEREFORE,


