A RESOLUTION DIRECTING ALL AGENCIES CONCERN TO CONDUCT A MASSIVE DENGUE FEVER INFORMATION CAMPAIGN AND TO ALLOCATE THE NECESSARY FUNDS FOR THE PURCHASE OF EQUIPMENT, MEDICINES AND CHEMICALS FOR THE CONTROL AND PREVENTION OF SAID DISEASE.

WHEREAS, as reported by the Department of Health (DOH), Quezon City, is included in the dengue watch list;

WHEREAS, an outbreak in dengue is declared when the case are generally higher than in the last five years while a hotspot is an area with clustering of cases plus death;

WHEREAS, there is an imminent need for the City government to adopt measures relevant to the prevention and control of such outbreak in order to safeguard the health of our populace;

WHEREAS, such measure should be disseminated by way of a massive information and awareness campaign regarding the dangers posed by dengue fever;

WHEREAS, the City government is urge to provide funding to produce equipment, medicines and chemicals necessary to combat such outbreak.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to direct, as it does hereby direct, all agencies concern to conduct a massive dengue fever information campaign and to allocate the necessary funds for the purchase of equipment, medicines and chemicals for the control and prevention of said disease.

RESOLVED, FURTHER, that Barangays who have purchase equipment be given medicines whenever they need.

RESOLVED, FINALLY, to furnish a copy of this Resolution to all agencies concern, for their information and guidance.
