RESOLUTION NO. SP **4017**, S-2007
(PR2007-167)

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO EXTEND FINANCIAL ASSISTANCE TO FIVE (5) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA ON AUGUST 29, 2007, AT SAN SIMON STREET, BARANGAY HOLY SPIRIT, DISTRICT II, THIS CITY, AT TWO THOUSAND PESOS (P2,000) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDS OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, a fire razed houses at the residential area of San Simon Street, Barangay Holy Spirit, District II, this City, on August 29, 2007.



BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to five (5) families affected by the fire that razed a residential area on August 29, 2007 at San Simon Street, Barangay Holy Spirit, District II, this City, at Two Thousand pesos (P2,000) per family owner and One Thousand Pesos (P1,000) per family renter/sharer which shall be taken from the Calamity or Emergency Funds of the City government or from any other available funds in the City Treasury.

RESOLVED, FURTHER, that the Social Services Development Department (SSDD), in coordination with Barangay Officials of Barangay Holy Spirit, shall authenticate the beneficiaries of this assistance.
