A RESOLUTION AMENDING RESOLUTION NO. SP-3863, S-2007 IN ORDER TO CHANGE THE BARANGAY AUTHORIZED THEREIN TO DISBURSE PORTION OF THE BARANGAY CALAMITY FUND FOR THE PROCUREMENT OF MEDICAL SUPPLIES AND RESCUE/EMERGENCY EQUIPMENT AND TRAINING PROGRAM AND FOR OTHER PURPOSES, FROM BARANGAY GREATER LAGRO TO BARANGAY FAIRVIEW.
