BELMONTE, JR., TO CONSIDER THE POSSIBILITY OF EXPANDING/REVISING THE SCHOOL SITE OF SAN DIEGO ELEMENTARY SCHOOL (SDES) BATASAN HILLS, QUEZON CITY IN ACCORDANCE WITH THE PROPOSED PLAN PREPARED FOR THE SCHOOL AND RECOMMENDED BY THE GENERAL PARENTS TEACHERS AND COMMUNITY ASSOCIATION AND TEACHERS CLUB ASSOCIATION AND TEACHERS CLUB ASSOCIATION OF SAN DIEGO ELEMENTARY SCHOOL.*

*WHEREAS, a location plan NGC Eastside Development Project (Portion) had been prepared for San Diego Elementary School (SDES) for its proposed expansion/revision of school site with a total area of Five Thousand Six Hundred Thirty Nine Square Meters (5,639 Sq.m), which is made an integral part hereof;*

*WHEREAS, the present site of San Diego Elementary School (SDES) is considered not to be strategically located that it poses danger to the lives and limbs of the students in case of emergency;*

*WHEREAS, the San Diego Elementary School (SDES) General Parents Teachers and Community Association (GPTCA) and Teachers CLUB Association (TGA) had filed its petition for the expansion/revision of the school;*


