BELMONTE, JR., CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE PRESIDENT OF THE PHILIPPINES — PRESIDENT'S SOCIAL FUND FOR THE CONSTRUCTION OF FIFTEEN (15) UNITS ARTESIAN WELLS, THROUGH VICE MAYOR HERBERT M. BAUTISTA, IN SELECTED AREAS OF THE CITY.

WHEREAS, the President's Social Fund of the Office of the President of the Philippines approved the request of Vice Mayor Herbert M. Bautista, MPA, MNSA, for the construction of fifteen (15) units of artesian wells in selected areas of Quezon City;

WHEREAS, the artesian well construction projects of Vice Mayor Herbert M. Bautista, MPA, MNSA, seeks to address the scarcity of water supply in areas where the services of water concessionaire, Maynilad Water Services, is inexistent;

WHEREAS, the Honorable Feliciano R. Belmonte, Jr., City Mayor, in his capacity as Local Chief Executive, who is exclusively authorized by law to enter into Memorandum of Agreements (MOA) for the City government, consented into entering into a Memorandum of Agreement with the Office of the President of the Philippines for the same project;

Bautista, MPA, MNSA, in selected areas of the city.
