WHEREAS, Mrs. Adelaida S. Lazaro is applying for a Special Permit from the City Council as a requirement for the issuance of business permit pursuant to Resolution No. SP-3153, S-2005;

WHEREAS, the applicant is authorized to maintain and operate an Off Track Betting Station by the Manila Jockey Club, Inc., subject to compliance of necessary requirements;

WHEREAS, Mrs. Adelaida S. Lazaro had been issued business name registration by the Department of Trade and Industry (DTI) under the name Sir Al's Store and OTB;

WHEREAS, Mrs. Adelaida S. Lazaro had complied with various requirements in securing its Business Permit.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Mrs. Adelaida S. Lazaro, to operate and maintain an Off-Track Betting Station at 14-A Tandang Sora corner General Ave. Quezon City, subject to the rules and regulations promulgated by the Games and Amusement Board.

RESOLVED, FURTHER, that Mrs. Adelaida S. Lazaro shall remit to the City Treasurer in lieu of all business taxes, a franchise fee of Three Percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of Two (2) years only and maybe renewed by the City Council.
