RESOLUTION NO. SP-4024 -2007 (PR2007-156)

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO EXTEND FINANCIAL ASSISTANCE TO SEVENTY-ONE (71) FAMILIES AFFECTED BY THE FIRE THAT RAZED A RESIDENTIAL AREA ON AUGUST 28, 2007 AT HALAMANAN AREA NEAR LITEX ROAD, BARANGAY COMMONWEALTH, DISTRICT II, THIS CITY, AT TWO THOUSAND PESOS (P2,000) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDS OF THE CITY GOVERNMENT OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, to extend financial assistance to Seventy One (71) families affected by the fire that razed a residential area on August 28, 2007 at Halamanan Area near Litex Road, Barangay Commonwealth, District II, this City, at Two Thousand pesos (P2,000) per family owner and One Thousand Pesos (P1,000) per family renter/sharer which shall be taken from the Calamity or Emergency Funds of the City government or from any other available funds in the City Treasury.

RESOLVED, FURTHER, that the Social Services Development Department (SSDD), in coordination with Barangay Officials of Barangay Commonwealth, shall authenticate the beneficiaries of this assistance.
