A RESOLUTION GRANTING A SPECIAL USE PERMIT TO MR. RUFO LLANZA ADVINCULA TO OPERATE AND MAINTAIN AN OFF-TRACK BETTING STATION (JLB OFF-TRACK BETTING STATION) AT #18 TEACHERS BLISS, BALONBATO, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD.

WHEREAS, JLB Off-Track Batting Station, is a duly registered entity, applying for a Special Permit from the City Council as a requirement for the issuance of a Business Permit pursuant to Resolution No. SP-3135, S-2005;

WHEREAS, the applicant is authorized to maintain and operate an Off-Track Betting Station by the Manila Jockey Club, Inc. and Philippine Racing Club, Inc.;

WHEREAS, JLB Off-Track Betting Station had complied with various requirements in securing it's Business Permit.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Mr. Rufo Llanza Advincula to operate and maintain an Off-Track Betting Station (JLB Off-Track Betting Station) at #18 Teachers Bliss, Balonbato, Quezon City, subject to the Rules and Regulations promulgated by the Games and Amusement Board.

RESOLVED, FURTHER, that JLB Off-track Betting Station shall remit to the City Treasurer, in lieu of all taxes, a franchise fee of three percent (3%) of the gross revenue herein granted, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.


RESOLVED, FURTHERMORE, that the authority herein granted shall be for a period of two (2) years only and it may be renewed by the City Council.


