RESOLUTION NO. SP-**4027**, S-2007
(PR2007-27)

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT GUTTED SEVERAL HOUSES AT GREENVILLE SUBDIVISION, BARANGAY TANDANG SORA, QUEZON CITY ON JUNE 19, 2007, IN THE AMOUNT OF FOUR THOUSAND PESOS (P4,000.00) PER FAMILY OWNER AND THREE THOUSAND PESOS (P3,000.00) PER FAMILY RENTER/SHARER, TO BE TAKEN FROM THE CALAMITY FUND OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY, AND FOR OTHER PURPOSES.

WHEREAS, on June 19, 2007, conflagration razed several houses in Greenville Subdivision, Barangay Tandang Sora, Quezon City, victimizing an estimated Forty-Four (44) families;

WHEREAS, as a gesture of sympathy and support, it is but fitting to extend financial assistance to the lowly fire victims;

WHEREAS, the City Council pursuant to Section 458 of Republic Act No. 7160, also known as the Local Government Code of 1991, is empowered to enact ordinances and appropriate funds for the general welfare of the city and its inhabitants.


NOW, THEREFORE,


