RESOLUTION NO. SP4028, S-2007 (PR2007-28)

A RESOLUTION GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE BEREAVED FAMILY OF THE LATE TEODORO CUADRA, BARANGAY KAGAWAD, BARANGAY SANGANDAAN, QUEZON CITY, WHO DIED ON JULY 25, 2006 DUE TO ACUTE CARDIO RESPIRATORY ARREST, CHARGEABLE *AGAINST* THE*APPROPRIATIONS* FORGRANTS. SUBSIDIES ANDCONTRIBUTIONS UNDER THE 2007 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late Kagawad Teodoro Cuadra had served Barangay Sangandaan, Quezon City, with utmost dedication, loyalty and fidelity;

WHEREAS, during his incumbency he initiated various projects for the development of the barangay and was also instrumental in the maintenance of peace and order which the residents continually enjoy at the moment;

WHEREAS, due to his serious ailment and untimely demise, his family is now facing a bleak future since almost all of his family savings have gone into medical and funeral expenses;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to the bereaved family of the late Teodoro Cuadra, Barangay Kagawad, Barangay Sangandaan, Quezon City, who died on July 25, 2006 due to Acute Cardio Respiratory Arrest, chargeable against the appropriations for Grants, Subsidies and Contributions under the 2007 Annual budget of the Office of the City Mayor or from any available funds of the City Treasury.
