RESOLUTION NO. SP4 1 0 4, S-2008 (PR2008-06)

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE CITY TO ADVANCE THE FUND AND UNDERTAKE THE WIDENING OF THE CONGRESSIONAL AVENUE EXTENSION FROM VISAYAS AVENUE TO LUZON AVENUE, BARANGAY PASONG TAMO, THIS CITY, TO BE REIMBURSED BY THE DPWH UPON AVAILABILITY OF ALLOTMENT.

WHEREAS, the Department of Public Works and Highways (DPWH) has a proposed project, the widening of Congressional Avenue Extension, from Visayas Avenue to Luzon Avenue, Pasong Tamo in Quezon City which remains pending and has yet to be implemented due to unavailability of funds;

WHEREAS, the Quezon City Government (QC-LGU), in line with its objective of decongesting traffic from Commonwealth Avenue and Elliptical Road and of preventing the area from being occupied by informal settlers, proposed to initially advance the amount of Fifty Eight Million Six Hundred Sixty Four Thousand Pesos (P58,664,000.00) to undertake the implementation of the aforementioned proposed project on the condition that the DPWH will reimburse the said amount once appropriated cash allotment becomes available;

WHEREAS, the said project will affect private properties thus payment for the affected portion is necessary;

WHEREAS, there are so many benefits to be derived from the subject project particularly in terms of greater mobility;

WHEREAS, the Quezon City Local Government and the Department of Public Works and Highways shall perform a coordinated effort for the success of the implementation of the proposed project.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a Memorandum of Agreement with the Department of Public Works and Highways (DPWH) for the City to advance the fund and undertake the widening of Congressional Avenue, from Visayas Avenue to Luzon Avenue, Barangay Pasong Tamo, this City, to be reimbursed by DPWH upon availability of allotment.
