A RESOLUTION GRANTING A SPECIAL PERMIT TO MR. NUMERO G. LIM TO OPERATE AND MAINTAIN AN OFF-TRACK BETTING STATION (OTB) AT LIMPAO FOOD HOUSE LOCATED AT 13-A MINDANAO AVENUE, BARANGAY PAG-ASA, QUEZON CITY SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD.

WHEREAS, Mr. Numero G. Lim had been issued business name registration by the Department of Trade and Industry (DTI) under the name Limpao Food House;

WHEREAS, Mr. Numero G. Lim had complied with various requirements in securing its business permit.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Mr. Numero G. Lim to operate and maintain an Off-Track Betting Station (OTB) at Limpao Food House located at 13-A Mindanao Avenue, Barangay Pag-asa, Quezon City subject to the rules and regulations promulgated by the Games and Amusement Board.


RESOLVED, FURTHER, that Mr. Numero G. Lim shall remit to the City Treasurer a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable to the City Treasurer during the lifetime of the measure.

RESOLVED, FINALLY, that the authority herein granted shall be for a period of two (2) years only and maybe renewed by the City Council.
