A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION ON CERTAIN REQUIREMENTS AS PROVIDED FOR IN ARTICLE VI, SECTION 4 OF THE QUEZON CITY ZONING ORDINANCE TO MR. SERGIO L. HILADO, JR., ON THE PROPOSED CONSTRUCTION OF A THREE (3) STOREY, THIRTY-THREE (33) UNITS STUDIO-TYPE APARTMENT BUILDING LOCATED AT 21-A CONCHU STREET, BARANGAY MASAGANA, PROJECT 4, DISTRICT III, QUEZON CITY.

Hilado, Jr., is applying for a Certificate of Exemption on the parking space requirements for the construction of three (3)-storey, thirty-three (33) units studio-type apartment building with lot area of 280 square meters located at No. 21-A Conchu Street, Barangay Masagana, Project 4, Quezon City;

Hilado, Jr., for the construction of a three (3)-storey, thirty-three (33) units, studio-type apartment building located at No. 21-A Conchu Street, Barangay Masagana, Project 4, District III, Quezon City.
