RESOLUTION NO. SP.4162 (PR2008-113)

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO EXTEND FINANCIAL ASSISTANCE TO THE MARCH 13, 2008 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF ONE HUNDRED FIFTY FOUR (154) FAMILIES AT DON PEPE STREET, BARANGAY STO. DOMINGO, DISTRICT 1, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUNDS THEREOF.

WHEREAS, on March 13, 2008 at Barangay Sto. Domingo, specifically Don Pepe Street was hit by fire that burned the houses of One Hundred Fifty Four (154) families, who are now in dire need of financial assistance most especially from the City government;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident;

WHEREAS, it is the primary duty of the City government to extend assistance to its less fortunate constituents.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Feliciano R. Belmonte, Jr., to extend financial assistance to the March 13, 2008 victims of fire that burned the residential houses of One Hundred Fifty Four (154) families at Don Pepe Street, Barangay Sto. Domigo, District I, Quezon City, at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the calamity or emergency fund of the City government or from any available source of funds thereof.
