A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE FORMER BARANGAY KAGAWAD GEORGE DIMAGIBA DAVID, JR., OF BARANGAY CULIAT, QUEZON CITY IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the bereaved family of the late former Barangay Kagawad George Dimagiba David, Jr. of Barangay Culiat, Quezon City, in the amount of Forty Thousand Pesos (P40,000.00) chargeable against the appropriations for Grants, Subsidies and Contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds in the City Freasury.
