*A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE SIXTY (60) FAMILIES RESIDING AT PUROK 3, LUZON AVENUE, BARANGAY CULIAT, QUEZON CITY, WHOSE HOUSES WERE GUTTED BY A FIRE THAT OCCURRED ON APRIL 22, 2008, IN THE AMOUNT OF THREE THOUSAND PESOS (P3,000.00) PER HOUSE OWNER AND TWO THOUSAND PESOS (P2,000.00) PER HOUSE RENTER/SHARER, TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR.*

*WHEREAS, to alleviate the plight of the fire victims and to enable them to start anew, an appropriate financial assistance must be extended to them by the City government.*



NOW, THEREFORE,


