A RESOLUTION EXPRESSING OUR ACCEPTANCE OF THE WARM DESIRE OF THE MUNICIPALITY OF LAL-LO, PROVINCE OF CAGAYAN TO ESTABLISH A SISTERHOOD RELATIONSHIP.
