WHEREAS, statistics show that health care is a major national problem, with four (4) out of ten (10) Filipinos dying every year because of the lack of proper medication;

WHEREAS, the "Cheaper Medicines Law" aims to address the problem of quality health care by making medicines accessible and affordable to the citizenry;

WHEREAS, the "Cheaper Medicines Law" also amends the provisions of the Intellectual Property Code to encourage competition by allowing local firms to test, produce and register generic versions of patented drugs, parallel importation by the government and private sector to import and distribute cheaper medicine and government use of patented drugs when the public interest is at stake;


WHEREAS, the "Cheaper Medicines Law" also grants the President the power to price ceilings on various drugs, upon the recommendation of the Secretary of Health which include drugs for chronic illnesses, prevention of diseases, and those in the Philippine National Drug Formulary (PNDF) Essential Drug List;

WHEREAS, the "Cheaper Medicines Law" will truly realize the State's commitment to uplifting the state of health and quality of life for the people.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to support, as it does hereby support the passage of the "Universally Accessible Cheaper and Quality Medicines Act of 2008" or the "Cheaper Medicines Law."
