A RESOLUTION AUTHORIZING THE BARANGAY COUNCIL OF BARANGAY PROJECT 6, DISTRICT 1, QUEZON CITY, TO PROHIBIT TRUCKS WITH 2.6 TONS WEIGHT OR MORE FROM ENTERING AND PASSING THROUGH ROAD 1 AND ROAD 3 IN BARANGAY PROJECT 6, WITHOUT PREJUDICE TO THE PROVISIONS OF THE QUEZON CITY TRAFFIC CODE.

WHEREAS, the Barangay Council of Barangay Project 6 with the agreement and support of the constituents residing therein has already approved Barangay Ordinance No. 2, S-2008, requesting authority to prohibit trucks with 2.6 tons weight from entering and passing through Road 1 and Road 3;

WHEREAS, these trucks have caused traffic problem and deterioration of main roads particularly in Road 1 and Road 3 causing great inconvenience to the motorists and pedestrians passing thereat;

WHEREAS, it is necessary to authorize the said prohibition to provide security and safety, not only to the residents but also to the motorists and visitors passing thereat.
