A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FORMER BARANGAY KAGAWAD MONICO E. **ESTUARIA** OFBARANGAY COMMONWEALTH, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), CHARGEABLE AGAINST THE **APPROPRIATIONS FOR** GRANTS, SUBSIDIES CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the late former Barangay Kagawad Monico E. Estuaria served Barangay Commonwealth as an elected barangay Kagawad for five (5) years commencing from May 1997;

WHEREAS, during his incumbency former Kagawad Estuaria was instrumental in various development projects in Barangay Commonwealth which greatly contributed to the progress of the said Barangay, as well as the upliftment of the economic condition of the residents therein;

WHEREAS, the untimely demise of former Kagawad Estuaria on April 27, 2007 due to heart attack caused his family to suffer not only emotional distress but also financial difficulty;

WHEREAS, Resolution No. 224, S-2007 adopted by the Sangguniang Barangay of Barangay Commonwealth, the members of the Sanggunian are appealing for financial assistance as a token of support to the bereaved family of former Kagawad Estuaria and in recognition of the latter's exemplary performance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to bereaved family of the late former Barangay Kagawad Monico E. Estuaria of Barangay Commonwealth, Quezon City, in the amount of Thirty Thousand Pesos (P30,000.00), chargeable against the appropriations for grants, subsidies and contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
