RESOLUTION NO. SP4 274 S-2008 (PR2008-203)

A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO ADOPT THE IMPLEMENTING RULES AND GUIDELINES SET BY THE TRICYCLE REGULATION UNIT (TRU) FOR THE NON-MOTORIZED TRICYCLES OR PEDICABS OPERATING WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY AS PROVIDED BY QUEZON CITY ORDINANCE NO. SP-1104, S-2002, KNOWN AS "THE QUEZON CITY PEDICAB ORDINANCE OF 2002".

WHEREAS, to regulate the proliferation of these non-motorized tricycle units or pedicabs, all pedicabs associations operating within the jurisdiction of Quezon City must apply for an accreditation with the office of the Tricycle Franchising Board;

WHEREAS, to become legitimate as one of the means of transportation within Quezon City, members of this pedicab associations must individually apply for the pedicab franchise as provided for under Ordinance No. SP-1104, S-2002 as amended by Ordinance No. SP-1277, S-2003;

WHEREAS, the office of the Tricycle Franchising Board must issue a Certificate of Franchise for all the members of the associations and the operator/owner must register with the office of the Tricycle Regulation Unit (TRU) in order for them to legitimately operate as for hire within the jurisdiction of Quezon City.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Quezon City Government to adopt the Implementing Rules and Guidelines set by the Tricycle Regulation Unit (TRU) for the non-motorized tricycles or pedicabs operating within the territorial jurisdiction of Quezon City as provided by Quezon City Ordinance No. SP-1104, S-2002, known as "The Quezon City Pedicab Ordinance of 2002".
