*A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE BARANGAY KAGAWAD FRANCISCO ORBE OF BARANGAY SAN AGUSTIN, NOVALICHES, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.*




