RESOLUTION NO. SP4294 S-2008 (PR2007-281)

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO FORMER POLICE CORPORAL VINCENTE L. SANCHEZ OF BARANGAY HOLY SPIRIT, THIS CITY, TO DEFRAY THE COST OF HIS MEDICAL TREATMENT FOR PROSTATE CANCER, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2008 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, he was diagnosed of prostate cancer and is undergoing medical treatment for the same, however, due to the rising cost of medicine he has difficulty raising the needed amount;

WHEREAS, the Quezon City Council deems it fit/proper to grant financial assistance to herein recipient not only in recognition of his dedication and service to the Quezon City Police District but also for just and humane purposes.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance in the amount of Thirty Thousand Pesos (P30,000.00) to former Police Corporal Vicente L. Sanchez of Barangay Holy Spirit, this City, to defray the costs of his medical treatment for prostate cancer, chargeable against the appropriation for grants, subsidies and contributions under the 2008 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
