WHEREAS, in a letter dated July 24, 2008 of Honorable Lino O. Montillo, City Mayor of the City of Tacurong, Sultang Kudarat addressed to Vice Mayor Herbert M. Bautista, the Chief Executive expressed its sincere desire to have a sisterhood tie with the Quezon City government;
